

## LOTTERY TERMS AND CONDITIONS

**THE FOLLOWING ARE THE TERMS AND CONDITIONS OF THE GREAT WESTERN AIR AMBULANCE CHARITY LOTTERY. BY COMPLETING THE PLAYER APPLICATION FORM AND/OR RENEWAL FORM, YOU AGREE THAT YOU HAVE READ AND UNDERSTOOD THESE TERMS AND THAT THEY WILL APPLY TO AND GOVERN YOUR PARTICIPATION IN THE LOTTERY. IF YOU DO NOT AGREE WITH ANY OF THE TERMS AND CONDITIONS, YOU SHOULD NOT ACCEPT THEM, IN WHICH CASE YOU WILL NOT BE ELIGIBLE TO PARTICIPATE IN THE LOTTERY.**

1. The Great Western Air Ambulance Charity Lottery (“the Lottery”) is a weekly subscription draw promoted by the Air Ambulance Lottery Society (“AALS”)
2. The object of the AALS is to support and assist air ambulance charities affiliated to it. One of the ways it does this is by promoting lotteries. The sole charitable beneficiary of the Lottery is the Great Western Air Ambulance Charity, which will receive all of the proceeds after deduction of the expenses of running the Lottery, including the cost of the prizes.
3. The AALS is licensed by the Gambling Commission, non-remote society operating licence no. 000-026952-N-308423-001.
4. The person responsible for promoting the Lottery (“Responsible Person”) is Mr J Naylor of the AALS, whose address is 16-18 Bank Street, Walshaw, BL8 3AZ.
5. As part of its constitution, the AALS ensures that a representative from Great Western Air Ambulance sits on its management committee.
6. The draw will take place every Tuesday at the offices of the AALS at the address set out in rule 4. Winning entries will be selected by means of random number generator software which has been examined and approved by an independent testing house approved by the Gambling Commission.
7. Each chance in the draw costs £1 [per week for the weekly draw].
8. Payment for tickets in the Lottery may be made by cheque, standing order, or direct debit.
9. Lottery subscriptions will be held in a ring-fenced holding account prior to each draw. We hold customer funds separate from AALS funds. This means that steps have been taken to protect customer funds but that there is no absolute guarantee that all funds will be repaid. This meets the Gambling Commission’s requirements for the segregation of customer funds at the level: medium protection. Full details are available within our Social Responsibility in Gambling Policy which is available on the website, or by contacting AALS at the address above.
10. Persons employed by the AALS, their partners and persons living in their household are not eligible to participate in the Lottery.
11. Upon receipt of your player application form, the AALS will issue you with (a) unique ticket number(s) [which will be entered into the draw each week. Your unique number(s) will be stored by the AALS together with your other details.
12. The AALS will store and process your data in accordance with the provisions of the Data Protection Act 1998 and subject to the terms of the AALS Privacy Policy, a link to which may be found at [www.airambulancelotteries.com](http://www.airambulancelotteries.com) and on the Great Western Air Ambulance Charity’s website, [www.gwaa.com](http://www.gwaa.com)
13. The winning numbers will be displayed on the AALS website, [www.airambulancelotteries.com](http://www.airambulancelotteries.com) and on the Great Western Air Ambulance Charity’s website, [www.gwaac.com](http://www.gwaac.com)
14. You may call the AALS on 0844 567 0844 to request a winners’ list. There is no need to check your numbers - if you are one of the lucky winners, the AALS will contact you as soon as possible by telephone or letter if you are a lucky winner.
15. No substitute will be offered for any prize in the Lottery.
16. The AALS reserves the right to reclaim any prizes issued in error.
17. Any prize unclaimed for a period of 6 months from the date of the draw will be deemed to be, and applied as if it were, a donation to the Great Western Air Ambulance Charity.

18. The Lottery is only open to persons aged 16 and over.
19. The AALS has in place policies and procedures designed to minimise the risk of lottery tickets being sold to children. In particular, it reserves the right to carry out independent age verification before allowing any lottery ticket to be sold to a person who appears to be aged under 16.
20. If, on completion of age verification, the customer is shown to be underage, any stake paid will be returned but any prize that might otherwise have been won will not be paid.
21. The AALS is a member of the Lotteries Council, through which it contributes to the Responsible Gambling Trust, which carries out research into the prevention and treatment of problem gambling, public education on the risks of gambling and the identification and treatment of problem gamblers.
22. The AALS is committed to promoting a responsible approach to gambling. In particular, the AALS has a policy permitting those who wish to do so, to self-exclude from gambling for a minimum period of 6 months. 23. The AALS's decision in any matter regarding the Lottery is final. The AALS will be bound by its Complaints and Disputes policy, a link to which may be found at [www.airambulancelotteries.com](http://www.airambulancelotteries.com) and on the Great Western Air Ambulance Charity's website, [www.gwaac.com](http://www.gwaac.com). Any unresolved disputes will be referred to the Independent Betting Arbitration Service ("IBAS").
24. It is each player's responsibility to keep AALS notified of any change in address or telephone number. All winning cheques will be sent to the individual's address registered with the AALS as at the date of the draw in question.
25. The AALS cannot accept any responsibility for any loss, delay or theft of any payment or communication sent by post, direct from a bank or building society, fax or email.
26. The AALS reserves the right in its absolute and sole discretion to reject an application to enter the Lottery or to terminate an individual's entry, subject to acting reasonably at all times.
27. If you are a lucky winner, your name will be used in promotional material unless you inform the AALS by calling them on 0844 567 0844 or by emailing them on [contact@airambulancelotteries.com](mailto:contact@airambulancelotteries.com) that you do not wish your name to be disclosed. You may, however, opt out of your location being disclosed by ticking the appropriate box on the player application form.
28. The AALS may change the rules of the Lottery at any time and at their discretion but will post the new rules on their website, [www.airambulancelotteries.com](http://www.airambulancelotteries.com) and on the Great Western Air Ambulance Charity's website, [www.gwaac.com](http://www.gwaac.com) before the changes take effect.
29. Players may withdraw from the Lottery at any time by calling the AALS on 0844 567 0844 or by emailing the AALS on [contact@airambulancelotteries.com](mailto:contact@airambulancelotteries.com). If you pay for your lottery tickets by standing order and you wish to withdraw from the Lottery, you should in addition ensure that you cancel your standing order.
30. Refunds of unused portions of monthly, quarterly or annual subscriptions may be made. Please allow up to 4 weeks for a refund to be processed.
